

RULES of TriCity Trail Junior 2018

1. Entry fee:

10 PLN

2. Age divisions and distance:

- D0 – up to 5 years old (2018 - 2013) — distance around 300 m;
 - D1 – 6 – 7 years old (2012 - 2011) — distance around 300 m;
 - D2 – 8 – 9 years old (2010 - 2009) — distance around 600 m;
 - D3 – 10 – 11 years old (2008 - 2007) — distance around 1 k;
 - D4 – 12 – 14 years old (2006 - 2004) — distance around 2 k;
 - D5 – 15 – 18 years old (2003 - 2000) — distance around 2 k;
- Distance of the races is approximate and might slightly change

3. Date:

The races will take place after the start of TriCity Trail Halfmarathon, according to the schedule:

- 09:10 – start of D0 and D1
- 09:25 – start of D2
- 09:35 – start of D3, D4 and D5

4. Entry details:

- Entries can be done from January 17, 2018 by online registration on www.tricitytrail.pl
- Entries also may be done personally at the race office on July 7th from 14:00 till 20:00 (at Upper Secondary School no.4 Sobieskiego st. 344) and on July 8th from 7:00 (in the City Park named after Majkowski in Wejherowo, close to Wybickiego street).
- The latest entry or bib pick up (for online registered participants) can be done 15 minutes before start of each age division.
- During registration or bib pick up presence of parents or legal guardians is necessary
- Responsibility of registration to an appropriate age divisions remains at parents or legal guardian.
- If a child runs in younger age division according to date of birth, he/she will be treated beside classification. They will get a medal, but won't be awarded in final classification.

5. Prizes:

- In age divisions: D0 and D1 - there won't be any classification, everyone will get the same prize: medal and a surprise gift.
- In age divisions D2, D3, D4, D5 prizes will be awarded to 1st, 2nd and 3rd places: in-kind prizes and statuettes.
- All participants will receive medals.

6. Personal data protection:

- Personal data of TriCity Trail Junior participants will be processed for the purpose of the event, selection of winners, awarding, issuing, receiving and the settlement of prizes and also for marketing purposes.
- Referring to the data processing from the first point of this paragraph, according to participation in the TriCity Trail Junior also includes the publication of the participant's first and last name along with the name of the town where he/she lives.
- The participant's supervisor has the right to review their personal data and correct them.
- Providing personal data and giving permission to its processing is voluntary, but its lack or disagreement to processing indisposes participation in the TriCity Trail Junior competition. By submitting to the organizer a correctly filled and signed application form, the guardian agrees and allows the use of the participant's personal data provided for the purpose of sending information, eg. e-mail, text message, regular letter, regarding future events, commercial products, data sharing to partners and event sponsors, as well as internal administrative and analytical needs, in accordance with the Personal Data Protection Act of August 29th 1997, Journal of Laws from No. 133, item 883. The guardian has the right to withdraw such consent and may do so at any time by directing correspondence to the address of the organizer.
- All information about participants obtained by the organizer and contained in the application form will be saved electronically and in any case will be used in accordance with the Act on the Protection of Personal Data of August 29th 1997, Journal of Laws from No. 133, item 883. The organizer has the right to share data obtained through the registration form with partners and event sponsors.

6. Final rules:

- Participants are obliged to have their racing bibs attached to the front of the body.
- When registering a participant for TriCity Trail Junior, guardian agrees to use of participant's image for TriCity Trail promotion.
- The organizer of TriCity Trail Junior reserves the right to change the regulations, of which it is obliged to inform all participants before the event by writing a message on the TriCity website.
- Binding and final interpretation of these regulations is only granted to the organizers of TriCity Trail.
- In matters which are not included in these Rules, the Rules of TriCity Trail Halfmarathon applies.
